It was in the year 2007 that Dr P K Gupta and Dr Sushil Kumar Chauhan realized the need to have a platform for doctors to upgrade their knowledge by organizing **CMEs** on regular basis . What started as a round table interactive discussion about latest developments in medicine with 6-7 doctors has now grown into a formidable group of 70 plus like minded doctors with a deep desire of an academic pursuit to upgrade their medical knowledge and skills. Eminent speakers from various specialities talk on recent advances in their respective fields. Equally important is the question and answer sessions which follow their talk making these **CMEs** academic fest for all the attending delegates. Since then this forum has organized more than 500 weekly **CMEs**. A need was felt to have a registered organization to scale up the academic activities of the group resulting in " Physicians Forum of India" which was duly registered as a Public Welfare Trust on 30th August 2016, with Dr P K Gupta and Dr. S K Chauhan as the authors of the trust and Dr S K Mathur, Dr Chandra Shekhar, Dr Sushrut Almast, Dr L M Parashar, Dr S K Poddar, Dr N K Gupta, and Dr Naveen Gupta as the Founder Trustees. Keeping in mind the duties of medical profession towards healthcare awareness of general public the trust included the same as a part of its main objectives.

1. Organizing weekly **CMEs** for doctors by eminent super specialists in different branches of medicines.(More than 500 **CMEs** organized till date)
2. Workshops on various super specialities (ENT Workshop on coblation) conducted by Dr Lalit Mohan Parashar at Apollo Spectra.
3. Health awareness camps for general public organized on awareness of diabetes, hypertension, thyroid, obesity, ENT, Eye checkups etc.
4. Digital Education for doctors by publishing our **CMEs** on various social media platforms (youtube, facebook, linkedin, twitter, smartican, tumblr etc.)
5. Health Awareness videos by eminent doctors
